Furthermore, the participant undertakes to indemnify and hold harmless the FIM, the FMNR, the FIM promoters, the organisers and officials, the employees, officers and agents, from and against any and all liability to third parties for any loss, damage or injury for which he is jointly and severally liable.

ACKNOWLEDGMENT AND AGREEMENT BY THE RIDER (Appendix 2 of the Anti-Doping Code)

I, the undersigned, as a member of an FMN and/or a competitor in an FMN or FIM authorised or recognised meeting, hereby acknowledge and agree as follows:

1. I have received and had an opportunity to review the FIM Anti-Doping Code.
2. I consent and agree to comply with and be bound by all of the provisions of the FIM Anti-Doping Code, including but not limited to, all amendments to the Anti-Doping Rules and all International Standards incorporated in the Anti-Doping Rules.
3. I acknowledge and agree that the FMN and the FIM have jurisdiction to impose sanctions as provided in the FIM Anti-Doping Code.
4. I also acknowledge and agree that any dispute arising out of a decision made pursuant to the FIM Anti-Doping Code, after exhaustion of the process expressly provided for in the FIM Anti-Doping Code, may be appealed exclusively as provided in Article 12 of the FIM Anti-Doping Code to an appellate body and in last instance for final and binding arbitration to the Court of Arbitration for Sport.
5. I acknowledge and agree that the decisions of the arbitral appellate body referenced above shall be final and enforceable, and that I will not bring any claim, arbitration, lawsuit or litigation in any other court or tribunal.
6. I have read and understand this Acknowledgement and Agreement.

The undersigned certifies the veracity of the above-mentioned information. He declares knowledge of the FIM Statutes, the Sporting Code and the Anti-Doping Code, in particular the provision which provides for the exclusive competence of the Court of Arbitration for Sport in Lausanne/Switzerland, the Enduro World Championship Rules and the Supplementary Regulations and commits himself to accept them and to conform with the directives of the FIM, the organisers and officials.
